A BYLAW TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE PROPERTY WITHIN THE SUMMER VILLAGE OF CASTLE ISLAND FOR THE 2018 TAXATION YEAR.

WHEREAS, the Summer Village of Castle Island has prepared and adopted detailed estimates of municipal revenue and expenditures as required, at the council meeting held on *May 15, 2018*; and

WHEREAS, the estimated municipal expenditures and transfers set out in the budget for the Summer Village of Castle Island for 2018 total \$304,446.97; and

WHEREAS, the requisitions are:

Alberta School Foundation Fund (ASFF)

- Residential \$30,718.00 - Non-residential \$46.00

Senior Foundation Requisition \$2,674.75
Designated Industrial Property Requisition \$0.51

WHEREAS, the council is authorized to classify assessed property, and to establish different rates of taxation in respect to each class of property, subject to the *Municipal Government Act*, Chapter M-26, Revised Statues of Alberta, 2000; and

WHEREAS, the assessed value of all property in the Summer Village of Castle Island as shown on the assessment roll is:

Assessment

Residential \$ 12,560,310

Non-residential \$ 14,890

WHEREAS, the estimated municipal revenues and transfers from all sources other than property taxation is estimated at \$204,722 and the balance of \$99,725.48 is to be raised by general municipal property taxation; therefore

Summer Village of Castle Island, in the Province of Alberta, enacts as follows:

Annual wastewater infrastructure levy of \$55 per tax account: 19 lots X \$55.00 = \$1,045.00Annual Fire agreement charge based on per tax account: 19 lots X \$95.82 = \$1,820.58Annual Lagoon – cc value charge per lot: 19 lots X \$183.82 = \$3,492.58
